The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm** on 2078/10/23 at the office of **Likhu Pike Rural Municipality Chaulakharka, Solukhumbu** Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Rs 300000** which shall be valid for 30 days beyond the validity period of the bid.
